

You Can Make a Tax Free Donation to the Kiwanis Club of Las Vegas Foundation The IRA Charitable Rollover is now permanent, allowing individuals aged 70 ½ or older to make <u>a tax-free distribution</u> from individual retirement accounts to the **Kiwanis Club of Las Vegas Foundation**, reducing their tax liability!

The Protecting Americans from Tax Hikes Act of 2015 has been signed into law. Among the many tax benefits made permanent was the IRA charitable transfer provision.

This provision allows individuals age 70½ or older to give up to \$100,000 from their IRAs directly to qualified charities - such as the **Kiwanis Club of Las Vegas Foundation** - without having to pay income taxes on the distributions and the donations count as part of the IRA owner's RMD required annual withdrawal.

There's no tax deduction for the donated assets; however, they are not included as income, either. To qualify for this break, **the donation must be transferred directly from the IRA custodian to the Foundation and gifts for 2016 must be made by the year-end.**
